To achieve Certificate II in Retail Cosmetics a total of 15 units must be completed

DURATION & DELIVERY

This course for high school students is delivered as a 12 months (1) year program, one day a week, broken down into terms and is as a competency based flexible learning program, the theory elements are classroom based, the practical elements are delivered in a simulated salon environment at LarShar College. It combines face to face teaching with small group training, with units being completed in a specific time frame.

RECOGNISED QUALIFICATIONS

Certificate II in Retail Cosmetics (SHB20121) is a nationally recognised qualification. The program is structured in line with the National Hairdressing and Beauty Training Package (SHB15).

CAREER PATHWAYS

This qualification provides a pathway to work as a retail sales consultant in any business that sells beauty or cosmetic products and services. This can include beauty and hairdressing salons, retail outlets and department stores.

FEES

If using VETis funding the program is full funded.

If no funding fees are broken down into terms. The programs are structured so that no kits are required for the relevant competencies being taught. All competencies include learner guides and relevant recourse.
